FREQUENTLY ASKED QUESTIONS

Why do some provinces have more draws than others?

Charitable gaming is regulated by each province and territory, and while there are many similarities across Canada, each province/territory has its own set of unique rules and regulations. The Canadian Olympic Foundation complies with the terms and conditions of each lottery license, which is why you see different draw schedules in each province/territory.

Are raffle tickets tax-deductible?

No official receipt for income tax purposes will be issued for the purchase of 50/50 tickets as set out by Canada Revenue Agency.

Am I able to get a refund?

All ticket sales are final. There will be no refunds issued to anyone for any reason. All tickets purchased and entered into the draw cannot be refunded, including if ticket purchasers made an error in selecting the number of tickets they wished to purchase.
