

PAW-SITION SUGGESTER: WHAT SPORT SHOULD YOUR DOG TRY? (the "Contest")
Official Rules

This Contest is organized and sponsored by the Canadian Olympic Committee, a national, private, not-for-profit organization responsible for Canada's participation in the Olympic Games, Youth Olympic Games and Pan American Games and the promotion of the Olympic Movement in Canada (the "**Contest Sponsor**"). The Contest is also presented by Nulo (the "**Contest Partner(s)**").

Contest starts at 12:00am ET on February 6, 2026 and ends at 11:59pm ET on February 22, 2026 (the "**Contest Period**").

By entering this Contest, entrants accept and agree to be bound by these Official Rules and accept the decisions of the Contest Sponsor as final and binding in all respects.

1. ELIGIBILITY

This Contest is open to all legal residents of Canada who have reached the age of majority in the province or territory in which they reside. Employees, agents and representatives of the Contest Sponsor or Contest Partner(s), their subsidiaries, affiliates, advertising and promotional agencies and all respective employees, shareholders, officers, directors, agents, members, licensees, successors and assigns of the foregoing (collectively the "**Contest Parties**") as well as members of their immediate family (spouse and parent, children, siblings and their respective spouses, regardless of where they reside) or persons living in the same household (whether related or not) are not eligible to participate in this Contest.

3. HOW TO ENTER

NO PURCHASE NECESSARY

- Click 1 answer to each of the questions that appear on screen
- Share your email, first name and last name
- Click SUBMIT
- Follow the instructions and submit your entry. Entries will not be eligible if sent by any method not specified above or if received after the end of the Contest Period. Winners will be selected randomly from all eligible entries. You may enter multiple times. The more entries completed, the greater your odds of winning.

4. ODDS OF WINNING

Odds of winning this Contest will depend upon the number of eligible entries received by the end of the Contest Period. All entries must be received by 11:59p.m. ET on February 22, 2026 in order to qualify. The Contest Sponsor will not be responsible for late, delayed, misdirected, lost, or incomplete entries. Entries that are incomplete, irregular, have been submitted through illicit means, or do not conform to or satisfy any condition of these Official Rules shall be disqualified.

5. PRIZING

For this Contest, there is one (1) prize available to be won, which consists of Trainers 4oz (2), Jerky Treats (3), Granola (1), Omega Oil (1), Samples- Lamb & Chickpeas dry food (3), Samples- LI Salmon dry food (3), 13 oz cans Turkey & Sweet Potato wet food (2), Scarf (1), Olympic Bandana (1) and Foam Finger Toy (1), valued at approximately \$200. All prizes must be accepted as awarded, are non-refundable and are not convertible to cash. The Contest Sponsor reserves the right to substitute any of the prizes, or any component thereof, with a prize of equal or greater value. The Prize(s) is/are transferable by the Winner as a gift to an immediate family member only and cannot be resold. If the winner cannot use or chooses not to use, for any reason, any portion of the Prize(s), that portion of the Prize(s) will be forfeited and no substitution or other compensation will be awarded. The Prize(s) can only be redeemed between February 23, 2026 – December 31, 2026.

6. SELECTING WINNERS

A random draw for the Prize(s) will be conducted at or about 12:00pm ET on March 9 by the Contest Sponsor from all eligible entries received.

The Contest Sponsor shall use commercially reasonable efforts to contact the Winner(s) using the contact information set out in their entries. In the event that a Winner cannot be contacted within five (5) business days of the random draw, the entry of such selected entrant shall be deemed void and the Contest Sponsor shall draw another entry at random from the remaining eligible entries. The process noted above will be repeated until a Winner has been contacted and has accepted the prize or until there are no more eligible entries, whichever comes first.

Before being declared a Winner, each selected entrant must first correctly answer without assistance of any kind, whether mechanical or otherwise, a time-limited mathematical skill-testing question within five (5) business days of prize notification.

Each Winner will also be required to sign a Declaration and Release Form (the “**Release Form**”) confirming compliance with these Official Rules, acceptance of the respective Prize as awarded without substitution. By entering into this Contest or accepting a Prize, participants give permission to the Contest Parties to use winners’ name, likeness, voice, quotes, comments, biographical information, image and/or any other content submitted by participants as part of the Contest for the purpose of promotion by the Contest Parties (including the Canadian Olympic Club) without further notice, permission, compensation or consideration in any and all media now known or hereafter developed, in any manner, throughout the universe, unless prohibited by law. Any content submitted by entrants for purposes of the Contest become the property of the Contest Parties and will not be returned.

By entering this Contest and accepting a Prize, if applicable, each entrants releases and agrees to hold the Contest Parties, harmless against any and all manner of actions, causes of action, suits, debts, covenants, contracts, claims, and demands, including legal fees and expenses, whatsoever, including but

not limited to, claims based on negligence, breach of contract, fundamental breach, liability for physical injury, death, or property damage which the entrant, Winner or their respective administrators, heirs, successors or assigns might have or could have, by reason of or arising out of the entrant's participation in this Contest and/or in connection with the acceptance and/or use by the entrant of the prize awarded, if applicable.
